Pursuant to the Amended Letter of Agreement signed by the Government of the Republic of El Salvador on February 5, 2015, we agreed that additional funds may be provided for these purposes, subject to the same terms and conditions as set forth in the Letter of Agreement signed on January 13, 2009 as amended, without further need to amend the agreement to reflect the amount of funds provided.




